The name of the dog and all the details as recorded at the Kennel Club must be given on this entry form. If an error is made the dog may be disqualified by the Committee of the Kennel Club. All dogs must be REGISTERED at the Kennel Club in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of posting of such applications may be required by the Kennel Club. Puppies under 6 months of age on the first day of the Show cannot be entered for competition. If a dog is in the process of Registration or transfer at the time entry is made, add the letters NAF or TAF as appropriate after it's name. The Kennel Club Authority to Compete number for dogs registered and resident outside the UK must be stated or the entry will be returned.
